

HFESNZ WORKFORCE DEVELOPMENT PROJECT UPDATE

A Notice of Motion was submitted to the HFESNZ committee by members of the PAB on the 3rd of March to trigger a rule change to the membership categories and their criteria. The Committee met on the 30th March and went through the

results of the Professional

members survey who were given the opportunity to vote and give feedback on the changes. The Committee agreed in principal to the 11 proposed changes to the membership categories and their criteria. These changes will be sent out to all

HFESNZ members 2 weeks prior to the AGM, and members will have the opportunity to vote on them (either in person or by proxy) at the AGM.

The documentation and processes have been developed and are under final review by the PAB.

An implementation plan for the changes has been developed.
