
### HFESNZ WORKFORCE DEVELOPMENT PROJECT UPDATE

#### Workstream 1 – Competency Framework (Rachael Gordon – Leader)

The latest version of the revised membership categories was presented to the HFESNZ Committee on the 13<sup>th</sup>of September. The PAB are planning to put these categories to the Professional members to vote in the next month, so look out for a questionnaire.

#### Workstream 2 – Education (Liz Ashby and Fiona Trevelyan – Leaders)

It has been a quiet past few weeks for workstream 2, with attention being given to writing relevant sections for the WorkSafe October report and contributing to the proposal for the next phase of the Workforce Development project. Having now a postgraduate education programme to meet the needs of Levels 3, 4, and 5 in the below diagram, thought is being given to entry level HFE education Levels 1 and 2 and how that might work in NZ.

#### Workstream 4 - Stakeholder Knowledge and Job creation (Rachael Gordon – Leader)

We are finalising the script this weekend, and will be meeting with the illustrator and animator in a week to get the animated video up and moving. We are currently planning the next "Human Factors and Ergonomics Awareness Resource" to be developed focusing on "Human Factors and Ergonomics for leaders". If anyone has any material that could be useful for this, please let Rachael know.

### HASANZ UPDATE

The HASANZ annual conference is scheduled for 16<sup>th</sup>-18<sup>th</sup> November. More information in the Events and Courses section below.

• PSPLA (Private Security Personnel Licensing Authority). Thanks to some very proactive work by HASANZ and others, there's been a positive outcome from the PSPLA issue. New legislation was at risk of requiring anyone who is involved in investigations being registered with the PSPLA (around \$500 per year) when it is designed more for ensuring the quality of security personnel.

HASANZ Registered Professionals (or members of HASANZ member societies) do not need to be licensed or certified by the Private Security Personnel Licensing Authority (PSPLA). Professionals that aren't registered with us will need to either join the Register or be licensed through the PSPLA.

• The Private Security Personnel Licensing Authority has recognised the value of HASANZ and Member Associations by concluding that:

- a. Health and safety auditors do not fit within the definition of private investigator in s 5 of the Act and accordingly are not required to be licensed or certified under the Act.
   b. Health and Safety professionals who are in the business of carrying out health and safety investigations are private investigators as defined by s 5 of the Act and, subject to the proviso below, should be licensed or certified with the PSPLA. This finding extends to health and safety investigator employees as defined in s13 of the Act.
- c. HASANZ and its member organisations are better placed than the PSPLA to regulate and have oversight of health and safety professionals. Therefore, any person on the HASANZ register or a member of a HASANZ member organisation is not required to also hold a licence or certificate with PSPLA, and complaints against them for failing to do so will not be accepted by the Authority.
- Engineering NZ (specifically process safety engineers) have joined HASANZ as a member organisation
- Work is continuing to finalise the HASANZ strategy. This is important to cement funding arrangements and associated workstreams. Please contact me if you want further information about the current draft Strategy or want to comment on it. Now is the time to provide feedback.

The HASANZ conference will finally take place in Wellington on the 16<sup>th</sup> (after our HFESNZ one day conference) after being repeatedly cancelled due to COVID. Go to <u>https://www.hasanz.org.nz/page-conference/</u> for more info. I'm looking forward to seeing some of you there. We may need to coordinate a team to take turns to be stationed at the HFESNZ promo material (not standing there for ages just the odd bit or lurking).
